- Gastronomy Festival by the Islamic Chamber of Commerce and Development (ICCD);
- B2B meetings;
- Awards ceremony for the best pavilions.

On this occasion, ICDT would be grateful if the Honorable Chambers in charge of Commerce and Industry in the OIC Member States would take the necessary measures to ensure the active participation of their respective countries and disseminate this information to the stakeholders concerned with trade development and economic operators to raise the level of Intra-trade among the OIC Member States.

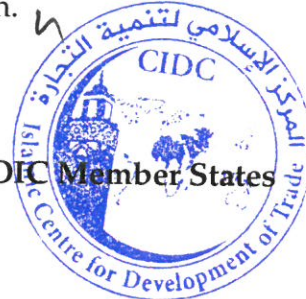
